This stay includes:

- Round trip ticket : Atlanta – The Base of Temple-sur-Lot
- All travels during the stay
- Accommodations at The Base of Temple-sur-Lot in quadruple rooms with bathroom
- Daily training (basketball and physical preparation) with professional coaches and a physical conditioning coach
- 3 daily meals at Tha Base of Temple-sur-Lot + a snack
- Cultural and recreational activities:
 - * 1 day: fun times at Walibi Park;
 - * 1 day in Bordeaux, a city classified as World Heritage by UNESCO in 2007: visit of Saint André Cathedral and the Pey-Berland Tower, of the Place de la Bourse and its reflecting pool. After a picnic at the Place du Quartier Saint Pierre, we will board the Yacht Le Luna (the only post-war yacht in Bordeaux) for a guided tour of one hour and a half from the Garonne; while enjoying a cannelé (a delicious Bordeaux pastry specialty) accompanied by a drink. And we will end with a little shopping in Sainte Catherine Street ;
 - * 1 day phisical conditionning/basketball in the morning and aquatic acitivity at La Base.

This 2 week stay for \$3000 (excluding liability insurance, repatriation, accident and health that are mandatory) is payable in 1, 3 or 5 times.

It is agreed as follows.

Article 1 : Purpose of the agreement

The Association TRANSITION GAME, represented by Mr Ronald STEWART, accompanies the children during the trip and throughout the stay in Joigny, wich will take place from July 17 to August 1, 2021.

Article 2 : General provisions

The sports program and the recreaional activities are established by Mr Ronald STEWART, President of the Association TRANSITION GAME. You will find attached the previonnal schedule ; The final schedule will be sent to you 3 days before departure. TRANSITION GAME reserves the right to cancel, modify or completely redesign the activities.

Article 3 : Disciplinary provisions

The camp counselors will be responsible for the children, during the entire stay.

On the other hand, they are in no way responsible for acts forbidden on the American territory, perpetrated by the children. That is why, each camper must stricly respect the rules and regulations and must not expose themselves voluntarily to any moral or physical danger, or that would put them in a criminal situation. US laws are particularly strict and we insist that the participants respect them scrupulously. Therefore, any of the following inappropriate behaviors would result in the immediate return of the participant from the camp at the expense of their parents or guardians : embarrassing behaviour of the child, an act likely to disrupt the group or the organization of the stay, the non-respect of the rules of safety or discipline dictated by the accompanying persons, hours during outings, rules of group life, theft, use or possession of drugs, consumption of alcohol and/or tobacco. The frequent application by Americans of zero tolerance of misbehavior means that the children who do not respect local rules and regulations are liable to immediate repatriation. Because we cannot take any risk in this matter.

Of course, the escort will be there to explain to them during the flight and on arrival at the college. Besides, a systematic reminder will be made before each outing.

Article 4 : Financial provisions

The parents of the participants will pay the amount of \$3000, including roud-trip airfare, accomodations, meal with full room and board, transport during the stay and all the additional costs as well as the activities organized by Transition Game.

All extra activities at the request of the chil or parents will be at their charge.

Article 5 : Health

Parents must provide a certificate stating the possible health problems of their child. In the event of illness, the participant must provide a certificate from his attending physician authorizing him to make this trip. All treatments must be known by the Camp Director at least one month before the departure date.

Article 6 : Terms of payment

Payments are made by check.

All checks (all of which must include the date of issue) must be submitted with the registration agreement and the information sheet.

Article 7 : Cancellation

1 – Cancellation by the participant

For any registration, beyond the legal withdrawal period of 7 days, the following fees will be retained in case of cancellation :

- more than 240 days before departure : 20 % of the amount of the stay ;
- between 180 and 240 days before departure : 75 % of the total amount of the stay ;
- 180 days before departure : 100 % of the total amount of the stay.

Therefore, we advise you to take out cancellation insurance.

2 – Cancellation or change of stay by TRANSITION GAME

Cancellation

TRANSITION GAME reserves the right to cancel their stay, especially if the number of participants is too low ; Each participant will be informed of the decision no later than 45 days before departure ; and TRANSITION GAME can offer an other destination. If no alternative solution is appropriate, TRANSITION GAME will reimburse the amounts paid.

Modification of departure date

It is possible with the time differences the departure or arrival dates can change by one day. The exact date will be confirmed 30 days before departure.

Modification of the content of the stay

If for any reasons of restrictions or organization, one of the proposed services (including a substantial element of the stay) could not be carried out, alternative services will be offered.

Cancellation related to the current pandemic situation

If for any reason related to the current pandemic situation, the camp cannot take place, Transition Game will reimburse you in full.
